In addition, it also functions as a Debit Card and allows you to make purchases from your checking account anywhere VISA Debit Cards are accepted.


PEFCU ATM Card

Qualifications:

VISA Debit Card You need to be at least 13 years of age,* have a Share Draft (checking) account[†], and be in good standing with the Credit Union.

PEFCU ATM Card You need to be at least 13 years of age,* have a Share (savings) account with a minimum \$5.00 balance, and be in good standing with the Credit Union.
